Monkeypox vaccination – eligibility and access

- Current prioritization for **Pre-Exposure Prophylaxis** (PReP) is based on locations with confirmed cases, i.e., high-risk, currently Toronto and Ottawa with a few additional locations starting soon

For technical advice/support:
